1-411 is \$2.50 per call & additional cost per minute with call completion and appears on your local telephone bill under "National Directory Assistance".

- PIC Freeze

The "PIC Freeze" (Preferred Interexchange Carrier Freeze) prevents anyone from switching your long-distance carrier without your explicit authorization with the LEC. If you have a "PIC Freeze" on your line(s), any request from a long-distance carrier will be rejected when it reaches your LEC. No one else, except you (the owner of the phone line) can lift or place a "PIC Freeze" with your LEC.
